Establish a foundation for digital transformation with Infor LN, an ERP system designed for discrete and complex manufacturing environments, supporting production models ranging from engineer-to-order to repetitive manufacturing.

From large, global, multi-site enterprises to smaller, single-site organizations, the platform is designed to meet the needs of discrete manufacturers, providing tools to manage operational complexity, integrate financials, and coordinate supply chain processes.

HISTORY AND EVOLUTION

Infor LN originates from technology developed by Baan Corporation in the 1990s. After Baan was acquired through SSA Global and later absorbed into [Infor](#), the product evolved into what is now Infor LN.

Over time, the platform has been redesigned with updated architecture, expanded industry-specific capabilities, and support for cloud deployment.

While its roots can be traced to the former Baan ERP, Infor LN is maintained and developed as a modern discrete-manufacturing system with significant advancements beyond the original Baan codebase.

DEPLOYMENT OPTIONS

Infor LN is available on-premises, hybrid, or in the cloud as CloudSuite Aerospace & Defense, CloudSuite Automotive, CloudSuite Industrial Enterprise, and LN in the Cloud.

The deployment options include multi-tenant AWS cloud hosting, traditional on-premises deployment, and mixed environments, giving organizations flexibility based on regulatory, infrastructure, or operational considerations

Wherever it is deployed, this ERP solution offers fast and cost-effective deployment on the shop floor and across the supply chain with integration to financials, quality management, service management, and order management.

Infor LN also includes industry-specific features, project lifecycle management, and integrated PLM capabilities that connect engineering, production, and supply chain workflows in a single system.

Its analytics (powered by Infor Birst) provide contextual dashboards and KPIs that support operational and financial visibility across business functions.
